**RELEASE OF SECURITY INTEREST IN TRADEMARKS**  
**L.A. DREYFUS COMPANY**

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “*Release*”) is made as of January 23, 2014, by COÖPERATIEVE CENTRALE RAIFFEISEN-BOERENLEENBANK B.A., “RABOBANK NEDERLAND”, NEW YORK BRANCH, as collateral agent (in such capacity, the “*Collateral Agent*”).

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated September 30, 2010 (the “*Trademark Security Agreement*”), by and between Wm. Wrigley Jr. Company, a Delaware corporation, Northwestern Flavors, LLC, an Illinois limited liability company, L.A. Dreyfus Company, a Delaware corporation and Lucas World, Inc., a Delaware corporation (collectively, jointly and severally, “**Grantors**”) in favor of the Collateral Agent, the Grantors have granted to the Collateral Agent a security interest in the Trademarks set forth in Schedule 1 (the “*Trademarks*”); and

WHEREAS, the Trademark Security Agreement (Trademarks) was recorded at Reel 004289, Frame 0675 on October 4, 2010; and

WHEREAS, the Grantors have requested that the Collateral Agent release its lien on the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby releases any and all claims, liens, and other encumbrances in and to the Trademarks and reassigns any and all rights, titles and interests therein, without any representation, recourse or undertaking by the Collateral Agent, to the applicable Grantors.


