**NOTICE OF CHANGE OF ADMINISTRATIVE AGENT AND COLLATERAL AGENT -  
ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

January 31, 2014

WHEREAS, SOPHOS LIMITED (formerly known as Sophos PLC) and SOPHOS INC. (together, the "Grantors") own all right, title and interest in and to the Patents (as defined in the Intellectual Property Security Agreement (as defined herein)) and Trademarks (as defined in the Intellectual Property Security Agreement) listed on Schedule A hereto (the "Intellectual Property");

WHEREAS, SHIELD FINANCE CO S.À R.L. ("Shield Finco"), SHIELD HOLDCO LTD ("Holdings"), SOPHOS HOLDINGS LIMITED ("Parent"), SOPHOS LIMITED ("Company"), each Lender from time to time party thereto, JPMORGAN CHASE BANK, N.A., as Administrative Agent and Collateral Agent (in such capacities, the "Existing Agent"), and each other party thereto have entered into the Credit Agreement dated as of June 15, 2010, as amended and restated as of July 13, 2010, as further amended and restated as May 10, 2012 (as further amended, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the "Original Credit Agreement"), pursuant to which the Lenders had severally agreed to make Loans to the Borrowers on the terms and subject to the conditions therein;

WHEREAS, in connection with the Original Credit Agreement, the Grantors have entered into the Intellectual Property Security Agreement dated as of August 5, 2011 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Intellectual Property Security Agreement"), in order to induce the Lenders to make Loans;

WHEREAS, pursuant to the Intellectual Property Security Agreement, the Grantors have granted to the Existing Agent, for the ratable benefit of the Secured Parties, a security interest in certain intellectual property of the Grantors, including the Intellectual Property, and such security interest was recorded in the United States Patent and Trademark Office;

WHEREAS, Shield Finco, the Company, Parent, Holdings, certain subsidiaries of Parent, Deutsche Bank AG New York Branch, as Administrative Agent and Collateral Agent (in such capacities, the "Successor Agent"), the Existing Agent, the New Term B Lenders (as defined in the Amendment Agreement (as defined herein)) and the New Revolving Credit Lenders (as defined in the Amendment Agreement) have entered into that certain Amendment No. 4 dated as of January 31, 2014 (the "Amendment Agreement"; the Original Credit Agreement, as amended by the Amendment Agreement, the "Credit Agreement"), whereby, among other things, the Lenders have consented to the resignation of the Existing Agent and the appointment of the Successor Agent and the New Term B Lenders and the New Revolving Credit Lenders have agreed to make new Loans to the Borrowers on the terms and subject to the conditions therein; and

WHEREAS, Shield Finco, Holdings, Parent, Company, certain subsidiaries of Parent, the Existing Agent and the Successor Agent, have entered into the Resignation, Waiver, Consent and Appointment Agreement dated as of January 31, 2014 (the “Resignation Agreement”), whereby, among other things, the Existing Agent resigns as Administrative Agent and Collateral Agent and is replaced by the Successor Agent as successor Administrative Agent and successor Collateral Agent under the Credit Agreement, the Intellectual Property Security Agreement and the other Loan Documents;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each party, the parties hereby agree and confirm that:


1. JPMorgan Chase Bank, N.A., has ceased to be the Existing Agent;
2. Deutsche Bank AG New York Branch is now the Administrative Agent and Collateral Agent under the Credit Agreement, the Intellectual Property Security Agreement and the other Loan Documents; and
3. Nothing herein shall be deemed to terminate or impair the continuity of the security interest in the Intellectual Property originally granted to the Existing Agent, which security interest is now succeeded by and transferred to Deutsche Bank AG New York Branch.

Unless otherwise defined herein or the context otherwise requires, the terms used in this agreement shall have the meanings provided or provided by reference in the Resignation Agreement or the Credit Agreement.


