RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of February 4, 2014 (“Effective Date”) by Silicon Valley Bank, as administrative agent (“Grantee”), in favor of Workspeed Holdings, LLC, a Delaware limited liability company, Workspeed Management, LLC, a Delaware limited liability company, Workspeed Notifications LLC, a Delaware limited liability company, and WS Merger LLC, a Delaware limited liability company (each a “Grantor” and collectively, the “Grantors”).

WHEREAS, pursuant to the terms and conditions of that certain Grant of Security Interest in United States Trademarks by and among the Grantors and Grantee dated June 24, 2011 (the “Trademark Security Agreement”), each Grantor granted to Grantee a continuing security interest in and to all of such Grantor’s right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by such Grantor (collectively, the “Trademarks”), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, together with the goodwill associated therewith;

WHEREAS, the Grantors and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Guarantee and Collateral Agreement by and among the Grantors, Grantee and certain other parties party thereto, dated January 15, 2010;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on June 24, 2011 at Reel 004569, Frame 0391 (in connection with which a corrective assignment was recorded with the PTO on June 28, 2011 at Reel 004571, Frame 0185); and

WHEREAS, the Grantors have paid all of their respective outstanding indebtedness to Grantee.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Grantee, at Grantors’ sole cost and expense, shall take all further actions, and provide to the Grantors and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Release.
