
IP SUPPLEMENT

This IP SUPPLEMENT, dated as of January 19, 2014, is delivered pursuant to and supplements (i) the Collateral Agreement, dated as of September 25, 2013 (said Collateral Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the “Collateral Agreement”), among Omnicell, Inc., a Delaware corporation, and MTS Medication Technologies, Inc., a Delaware corporation (each a “Grantor”), the other Grantors named therein, and Wells Fargo Bank, National Association, as Administrative Agent, and (ii) the Grant of Trademark Security Interest and Grant of Patent Security Interest in each case dated as of September 25, 2013 (the “Grant”) executed by each Grantor. Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Grant.

Each Grantor grants to the Administrative Agent a security interest in all of Grantor’s right, title and interest in and to the Trademark Collateral and Patent Collateral, as applicable, set forth on Schedule A annexed hereto. All such Trademark Collateral and Patent Collateral shall be deemed to be part of the Trademark Collateral and Patent Collateral, as applicable, and shall be hereafter subject to each of the terms and conditions of the Collateral Agreement and the Grant. After reasonable inquiry, no Grantor is aware of any claim that is pending or threatened in writing by any third party that any material Intellectual Property Collateral set forth on Schedule A annexed hereto is invalid or unenforceable except as described on Schedule A hereto.

IN WITNESS WHEREOF, each Grantor has caused this IP Supplement to be duly executed and delivered by its duly authorized officer as of January 20, 2014.
