Assignor further covenants that it will at any time and at the request of Assignee execute such documents and take such other action that in the opinion of Assignee may be desirable or necessary to secure to Assignee, its successors, legal representatives and assigns, all rights conveyed and intended to be conveyed by this instrument, provided, that any reasonable out-of-pocket expenses incurred by Assignor in connection with the foregoing shall be reimbursed by Assignee.
