

Pursuant to the provisions of the South Dakota Business Corporation Act, the undersigned corporations submit the following Articles of Merger:

1. The parties to the merger are as follows:

Novozymes BioAg, Inc.	corporation	Delaware

2. The survivor will be **Novozymes BioAg, Inc.**, the parent company of TJ Technologies, Inc. and the survivor is the owner of all of the outstanding shares of the stock of TJ Technologies, Inc.

3. The amendments to the survivor's articles of incorporation will be as follows:


The participation of Novozymes BioAg, Inc. was duly authorized as required by its organic law.

7. These Articles of Merger will become effective on June 28, 2013 at 11:59 p.m. EST.


