TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is made as of the 4th day of February 2014, by and between HEALTH PRODUCTS CORPORATION, a corporation organized under the laws of the State of New York, with a business address at 1060 Nepperhan Avenue, Yonkers, NY 10703 ("Assignor"), and GLAXOSMITHKLINE, LLC, a limited liability company organized under the laws of the State of Delaware, with a business address at 5 Crescent Drive, Philadelphia, PA 19112 ("Assignee").

WHEREAS, Assignor and Assignee have entered into a Sale and Acquisition Agreement (the "SAA"); and

WHEREAS, among the assets to be transferred by Assignor to Assignee under the SAA are Assignor's rights in and to the trademark set forth in Schedule A attached hereto and any variants thereof (the "Trademark");

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby sell, assign, and transfer to Assignee all its right, title and interest in the Trademark in the world, including, without limitation, the U.S. trademark registration therefor set forth on Schedule A, all common law rights in and to the Trademark in the United States, any and all other rights in the Trademark in the world to the extent that such rights exist, the goodwill associated with the Trademark in the world, and all claims for damages or other remedies by reason of past or future infringement(s) of the Trademark, with the right to sue for and collect the same.

FURTHERMORE, Assignor shall execute and deliver to Assignee such additional documents as may be reasonably necessary to give full effect to the assignment and transfer of the rights, title and interest in and to the Marks hereunder, provided that Assignee shall be solely responsible at its own expense for all recordations of the assignment and transfer with the United States Patent and Trademark Office and/or other appropriate government offices.

This Assignment shall be binding upon the successors and assigns of Assignor and Assignee. This Assignment shall be governed by, interpreted under, and construed and enforced in accordance with the laws of the State of Delaware, without regard to the conflict of laws principles thereof. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement.
