TRADEMARK ASSIGNMENT

This Trademark Assignment (the "**Assignment**") is entered into this 28th day of January, 2014 by and between Greene, Tweed of Delaware, LLC, a Delaware corporation having an address of 1105 North Market Street, Suite 1300, Wilmington, Delaware 19801 ("**Assignor**") and Greene, Tweed Technologies, Inc. a Delaware corporation having an address of 1105 North Market Street, Suite 1300, Wilmington, Delaware 19801 ("**Assignee**").

WHEREAS, under that certain Intellectual Property Agreement dated as of December 31, 2013 (the "**Closing Date**"), Assignor transferred and assigned to Assignee all of Assignor's interest in the IP Rights (as defined in the Intellectual Property Agreement), including the trademarks set forth on Schedule 1 attached hereto and incorporated herein by this reference, including all common law trademark rights in the marks and any applications and registrations therefor throughout the world (the "**Marks**"), effective as of the Closing Date; and

WHEREAS, under the Intellectual Property Agreement, Assignor and Assignee agreed to enter into this Agreement and any other agreements necessary to effect the transfer and recordation of the IP Rights.

NOW, THEREFORE, in consideration of the sum of One Dollar and other good and valuable executed consideration, the full receipt and sufficiency of all of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby sells, transfers, conveys and assigns to Assignee, and Assignee hereby accepts from Assignor, all right title, and interest in and to the Marks together with the goodwill associated with the Marks, including any trademark registrations thereof and applications therefor, as well as all common law rights thereto. Assignee shall have the sole right to sue and collect damages and/or profits for both past and present infringements of the Marks.

2. Assignee, at its own cost and expense, shall record a fully executed copy of this Assignment with the United States Patent and Trademark Office and any other agency having jurisdiction over the ownership of the Marks, including all foreign trademark offices having jurisdiction over the Marks shown in Schedule 1 attached hereto.
