WHEREAS, by that certain Assignment for Security (Trademarks) dated July 18, 2012 ("Second Security Agreement"), recorded in the Trademark Assignment database of the PTO on July 26, 2012 at Reel/Frame 4829/0684, Fife, Tidland, and Maxcess International granted to Wells Fargo a continuing interest in all of its right, title and interest in, to and under the "Collateral" (as defined therein), including without limitation U.S. Trademark Registration Nos. 4249488, 4241527, 3174612, 3380014, 3337495 and 2991077, all as identified in Section E of Schedule 1 (the "Additional Trademarks");

**F. Merger of Wachovia Bank with Wells Fargo**

WHEREAS, Wachovia Bank merged with and into Wells Fargo Bank, National Association with an address at 14241 Dallas Parkway, Suite 900, Dallas, Texas 75254 ("Wells Fargo") on effective March 20, 2010 (the "Merger");

WHEREAS, pursuant to the Merger, evidence of which was recorded in the Trademark Assignment database of the PTO on March 5, 2013 at Reel/Frame 004975/0081, Wells Fargo is the successor in interest to all of Wachovia Bank's right, title and interest in and to the Fife Original Trademarks, Tidland Original Trademarks, Maxcess Original Trademarks, MPSI Original Trademarks and the Additional Trademarks (collectively, the "Trademarks");

**G. Release of Security Interest**

WHEREAS, Wells Fargo wishes to provide a document suitable for recording in the Trademark Assignment Database of the PTO for purposes of recording the release, relinquishment and discharge of its security interest in the Trademarks;

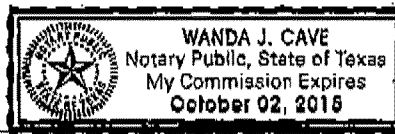
