1. I am currently the Executive Vice President and General Counsel of Synchronoss Technologies, Inc., a Delaware corporation with a principal place of business at 200 Crossing Boulevard, 8th Floor, Bridgewater, New Jersey, 08807
2. On May 7, 2012, Synchronoss Technologies, Inc. acquired the assets of SpeechCycle, Inc., a Delaware corporation with an address of 535 West 34th Street, New York, New York, 10001.
3. I served as Vice President of SpeechCycle, Inc. until its dissolution.
4. Consistent with and as part of the May 7, 2012 transfer, SpeechCycle, Inc. assigned, and Synchronoss Technologies, Inc. acquired, all right, title and interest in and to SpeechCycle Inc.'s trademarks, both registered and at common law, including those shown on the attached Schedule A, together the goodwill relative thereto.
