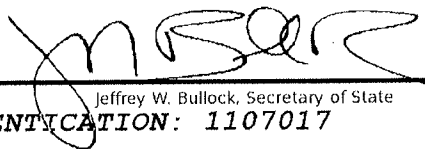

**SECOND:** Article FIRST of the Corporation's Certificate of Incorporation is hereby amended in its entirety to read as follows:

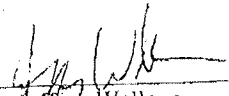
"**FIRST:** The name of the corporation is DSI/DataSource, Inc."
