

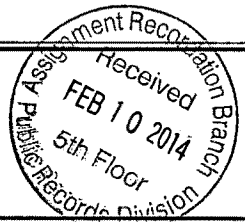

REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is executed as of January 17, 2014 by NXT CAPITAL, LLC, a Delaware limited liability company ("Assignor") for the benefit of TRADEKING GROUP, INC., a Delaware corporation ("Assignee").

RECITALS

A. C. WHEREAS, Assignor wishes to release and reassign all interest that Assignor may have in the IP.
