

The Assignor hereby assigns, grants and conveys to the Assignee, and its successors and assigns, all right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by and associated with said Trademarks in the United States and all countries throughout the world, and the right to sue for past, present, and future infringements and unauthorized uses of the Trademarks, including all available remedies.
2. The Assignor will, upon request of the Assignee, execute any other documents which may be necessary or appropriate to perfect in the Assignee the rights, title and interest herein conveyed in the United States or any other country.
3. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same instrument.
