TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “Release”) is made as of February 12, 2014, by GENERAL ELECTRIC CAPITAL CORPORATION, in its capacity as administrative agent (in such capacity, the “Agent”), in favor of NEXTMEDIA OPERATING, INC., a Delaware corporation (“Grantor”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, the Agent and Grantor are parties to that certain Trademark Security Agreement dated as of July 18, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), pursuant to which Grantor granted to the Agent a lien on and security interest in, among other things, the Trademark Collateral set forth therein, including, without limitation, the Trademarks set forth on Schedule I annexed hereto; and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 18, 2013 at Reel 5073, Frame 0001; and

WHEREAS, Grantor has requested that the Agent release its lien on and security interest in the Trademark Collateral, and to reconvey any and all rights in the Trademark Collateral to Grantor.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged:

1. The Agent hereby releases its lien on and security interest in and to all of Grantor’s right, title and interest in, to and under all of the Trademark Collateral.
2. The Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by the Agent, all of the Agent’s right, title and interest, if any, in and to the Trademark Collateral.
