RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of February 11, 2014 (the "Effective Date"), by WILMINGTON TRUST, NATIONAL ASSOCIATION, as collateral agent (in such capacity, the "Collateral Agent"), in favor of TRIMARK ERF, INC., FEDERIGHI DESIGN, INC. and STRATEGIC EQUIPMENT AND SUPPLY CORPORATION (each a "Pledgor", collectively, the "Pledgors").


WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement between the Pledgors and the Collateral Agent dated as of March 29, 2013 (the "Trademark Security Agreement"), the Pledgors pledged and granted to the Collateral Agent a lien on and security interest in all of their right, title and interest in and to certain collateral identified in said Trademark Security Agreement including, without limitation, the trademark applications set forth on Schedule I hereto, along with the goodwill associated therewith (collectively, the "Trademarks");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the Trademarks arising under the Trademark Security Agreement.

If and to the extent the Collateral Agent has acquired any right, title or interest in or to any of the Trademarks, it hereby irrevocably re-assigns and re-transfers all such rights, title and interest to the Pledgors.
