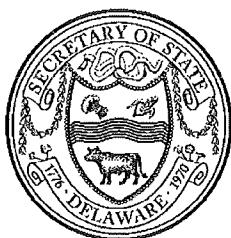



"FIRST: The name of the limited liability company is Advanced Refreshment LLC."


