AND WE HEREBY further covenant and agree that we will communicate to said ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting said Trademark, and testify in any legal proceeding, sign all lawful papers, execute all continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to assist said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for said Trademark in all countries.
