**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 14, 2014 ("Release"), is made by **SIGULER GUFF DISTRESSED OPPORTUNITIES FUND III, LP**, ("Agent") in favor of **PARADIGM SPINE, LLC** and **FOURTH DIMENSION SPINE, LLC** (collectively, "Debtors").

**WHEREAS**, pursuant to that certain Intellectual Property Security Agreement dated as of June 29, 2011 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement"), by and among the Debtors party thereto and the Agent, each Debtor granted to the Agent, for the benefit of the Secured Parties, a continuing security interest in, and a right to set off against, any and all right, title and interest of such Debtor in, to, and under all the Trademarks, Trademark Licenses, and Proceeds of the foregoing;

**WHEREAS**, pursuant to the Security Agreement, Debtors executed and delivered to Agent, for the benefit of the Secured Parties, the Notice of Grant of Security Interest in Trademarks dated as of June 29, 2011 ("Notice"); and

**WHEREAS**, the Notice was recorded at the United States Patent and Trademark Office ("USPTO") on June 29, 2011, at Reel 4577 Frame 0686.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent, on behalf of the Secured Parties, and Debtors agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

**SECTION 2. Termination and Release.** Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under all the Trademarks, Trademark Licenses, and Proceeds of the foregoing, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Debtors' expense.

**SECTION 3. Further Assurances.** The Agent hereby covenants that, from time to time after the delivery of this Release, at the Debtor's request in writing and at the sole expense of the Debtor, the Agent will do, execute, acknowledge and deliver, or will cause to be done, executed, acknowledged and delivered such further and documents as the Debtor may reasonably require to effectuate the release and discharge of the security interests and liens described above.


**SECTION 4. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the state of New York.
