RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release") dated February 18, 2014 is made by PNC Bank, National Association having a business address at One Financial Parkway, Kalamazoo, MI 49009, Mailstop: Z1-YB42-01-2, the successor in interest to RBC Bank (USA), a North Carolina Banking corporation (hereinafter PNC and RBC collectively referred to as "Secured Party"), and Good Health Natural Products, Inc., a Delaware corporation, having a business address at 3400 W Wendover Ave, Ste E., Greensboro, NC 27407-1523 ("Debtor").
