**ACKNOWLEDGEMENT OF TERMINATION AND RELEASE OF THE
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Acknowledgment of Termination and Release of the Intellectual Property Security Agreement (this "*Acknowledgement of Termination*") is executed by Hercules Technology II, L.P. a Delaware limited partnership ("*Lender*") in favor of Cozi Group Inc., a Delaware corporation (the "*Borrower*").

R E C I T A L S

B. WHEREAS, reference is hereby made to the Intellectual Property Security Agreement, dated as of May 6, 2008 (as amended, modified, renewed or extended from time to time, the "*Security Agreement*"), between Borrower and Lender, pursuant to which the Borrower granted to Lender a security interest in certain of Borrower's present and future assets, including the copyrights, patents, and trademarks identified on Schedule A attached hereto, to secure the Secured Obligations (as defined in the Loan Agreement);

C. WHEREAS, the Security Agreement was filed with the Trademark Division of the United States Patent and Trademark Office on May 6, 2008, at Reel No. 003772 at Frame No. 0719, to evidence the security interest granted under the Security Agreement;

D. WHEREAS, in connection with the repayment of the loan pursuant to the Loan Agreement, the Secured Party has agreed to terminate and release its security interest in Borrower's copyrights, patents, and trademarks, including, without limitation, those identified on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby acknowledges the termination and release, as of June 18, 2008 and in connection with the repayment of the loan pursuant to the Loan Agreement, of its security interest in all of the Borrower's copyrights, patents, and trademarks including, without limitation, those referred to on Schedules A, B and C hereto, and all proceeds of the foregoing.
