In connection with an Agreement of Merger, dated June 30, 2006 (the "Agreement of Merger"), by and between Euromoney, Inc., a Delaware corporation (the "Corporation"), and MIS Training Institute LLC, a Delaware limited liability company (the "LLC" and together with the Corporation, the "Constituent Entities"), pursuant to which the LLC will be merged with and into the Corporation (the "Merger"), the undersigned hereby certifies as follows:

5. An executed copy of the Agreement of Merger is on file at the principal place of business of the Corporation at 498 Concord Street, Framingham, Massachusetts 01702, and a copy of the Agreement of Merger will be furnished by the Surviving Entity, on request and without cost, to any stockholder or member of either of the Constituent Entities.

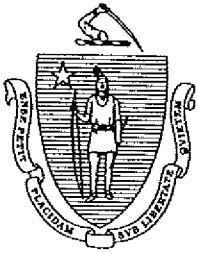
