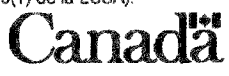

**Schedule/Annexe**

No shares of the capital and no other securities of the corporation, other than non-convertible debt securities, shall be transferred without either (a) the approval of the directors of the corporation evidenced by a resolution of the board entered in the books of the corporation or (b) the approval in writing of the holders of shares to which are attached more than 50% of the votes that may be cast to elect the directors of the corporation.

The directors may appoint one or more additional directors, who shall hold office for a term expiring not later than the close of the next annual meeting of shareholders, but the total number of directors so appointed may not exceed one third of the number of directors elected at the previous annual meeting of shareholders.
