The Brickman Group Ltd. LLC, a Delaware limited liability company (the "Company"), does hereby certify to the following facts relating to the merger (the "Merger") of Brickman Patriots Inc., a Massachusetts corporation (the "Subsidiary"), with and into the Company, with the Company remaining as the surviving entity:

FIRST: The names and jurisdictions of formation of each of the constituent entities which are to merge in the Merger are as follows:

THIRD: The name of the surviving entity is "The Brickman Group Ltd. LLC" (the "Surviving Entity"). The certificate of formation of the Company in effect immediately prior to the Effective Time (defined below) shall be the certificate of formation of the Surviving Entity.
