1. **ASSIGNMENT.** Assignor hereby assigns to Assignee and its successors and assigns, without any restrictions, reservations, or limitations, the entire and exclusive rights, titles, and interests in and to the Marks, including, without limitation, the United States and Canadian trademark applications and registrations therefor, together with the goodwill of the business symbolized by the Marks and the sole right to enforce rights in said Marks.

2. **GOVERNING LAW.** This Assignment shall be interpreted and construed in accordance with the laws of the State of Indiana without regard to its conflict of law rules or principles.

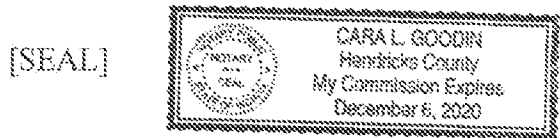

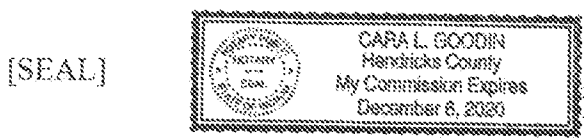
