Re: Payoff and lien release of Sovereign Bank

To Whom It May Concern:

This letter memorializes the release of any lien or security interest by Sovereign Bank ("Sovereign") with respect to trademarks of Munire Furniture Co., Inc. (the "Borrower").

Sovereign filed a security agreement with the USPTO on August 2, 2006, recorded at Reel 3374/ Frame 0016, (the "3374/0016 Assignment") in connection with a loan transaction. That loan was repaid by the Borrower contemporaneous with the filing of a security interest by Bank Leumi USA (the "Lender") with the USPTO on March 15, 2011, recorded at Reel 4498/ Frame 0307, (the "4498/0307 Assignment") in connection with a loan transaction.

For reasons unknown at this time, neither Sovereign nor the Lender filed a release of the 3374/0016 Assignment at the appropriate time; neither did either party file a UCC-3 termination statement, which is partly explained by the evident lack of a UCC-1 filing by Sovereign contemporaneous with its 2006 loan transaction.

In any case, Sovereign has been fully repaid, the 3374/0016 Assignment is void by operation of law, and the 4498/0307 Assignment is valid subject to its terms.

For these reasons, we write to give this notice and explanation of the termination of the 3374/0016 Assignment filed by the Borrower.
