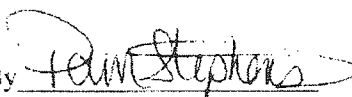
**CERTIFICATE OF AMENDMENT OF CERTIFICATE OF INCORPORATION
OF PERFECT EQUIPMENT INC.**

PERFECT EQUIPMENT INC. (the "**Corporation**"), a corporation organized and existing under the General Corporation Law of the State of Delaware, hereby certifies as follows:

1. This Certificate of Amendment (the "**Certificate of Amendment**") amends the provisions of the Corporation's Certificate of Incorporation filed with the Secretary of State on December 6, 2004 (the "**Certificate of Incorporation**").
2. Paragraph FIRST of the Certificate of Incorporation is hereby amended and restated in its entirety as follows:

FIRST. The name of the Corporation is Wegmann Automotive USA Inc.
3. This amendment was duly adopted in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.
4. All other provisions of the Certificate of Incorporation shall remain in full force and effect.
5. This amendment is to be effective January 1, 2014.
