DECLARATION OF SUNIL KHEMANEY

I, Sunil Khemaney, declare:


1. I am older than eighteen years old and I have personal knowledge of the facts set forth in this Declaration. I currently am the Executive Director of Wai Lana Productions, LLC.
2. The Applicant for U.S. Trademark Application Serial No. 78202229 ("the Trademark Application"), which matured into U.S. Registration No. 3769280 ("the Registration"), for LITTLE YOGIS, was the Trustees of the Wai Lan Yoga Trust.
3. In 2009, the Trustees of the Wai Lan Yoga Trust assigned the Trademark Application to Wai Lana Productions, LLC. See reel/frame 4122/0446.
4. In April 2012, Wai Lana Productions, LLC partially assigned to Bibiji Inderjit Kaur Puri ("Bibiji") the Registration for goods in IC 29 and 30 only. See reel/frame 4758/0848. Wai Lana Productions, LLC retained ownership of the Registration for goods in IC 9, 16 and 28.
5. In September 2012, Wai Lana Productions, LLC requested that the USPTO divide the Registration so that the assigned portion of the Registration for goods in IC 29 and 30 would be in a separate child registration for the LITTLE YOGIS mark.

6. In October 2013, the USPTO amended the Registration for the LITTLE YOGIS mark to divide out the goods in IC 29 and 30 for the LITTLE YOGIS mark into a separate registration, namely U.S. Registration No. 4412548 ("the Child Registration").

7. The Registration, as amended, is for the LITTLE YOGIS mark in connection with goods in IC 9, 16 and 28. Bibiji owns no interest in the amended Registration. Wai Lana Productions, LLC is the owner of the entire interest in the amended Registration.

The undersigned being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements may jeopardize the validity of the application or any resulting registration, declares that all statements made of his/her own knowledge are true and that all statements made on information and belief are believed to be true.
