

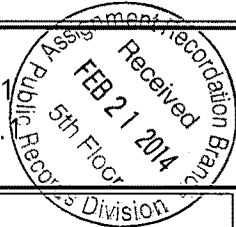

TRADEMARK RIGHTS ASSIGNMENT AGREEMENT

This Agreement ("Agreement") is by and between John Kim, an individual ("Owner") and Rhino House, LLC, a California Limited Liability Company ("Company").

Whereas, Owner is the named owner of U.S. Trademark Registration Number 3009383 (the "Trademark"), registered October 25, 2005, for the Rhino House logo mark; and


Whereas, Owner has formed a California limited liability company in order to continue his business as an LLC and intends to hold the Trademark in the Company.

2. This Agreement constitutes the entire understanding between the parties and supersedes any earlier understandings. Any modification to this Agreement shall be in a writing signed by the parties.
3. The parties have each read this Agreement and understand its contents and that it legally binds the parties. Each of the parties received the advice of competent legal counsel or had the opportunity to do so.
4. Should any portion of this Agreement be deemed invalid or unenforceable, it is the parties' intent that the remainder of the Agreement be fully enforced to the greatest extent possible.
