ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT (the "Agreement"), effective as of February 19, 2014 made by Golden Scorpio Corp., an Arizona corporation ("Assignor"), for the benefit of J.Y.R.C. LLC, an Arizona limited liability company ("Assignee").

WHEREAS, Assignor has agreed to contribute, sell, grant, convey, transfer and assign to Assignee the Trademarks and the IP.



Assignor does hereby sell, transfer, convey, assign and deliver to Assignee all right, title, and interest in and to the Trademarks and IP together with the goodwill of Assignor's business and the trademark rights pertaining thereto the same to be held by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns and other legal representatives; together with all claims for damages by reason of past infringements of the Trademarks and IP, along with the right to sue for and collect such damages for the use and benefit of Assignee and Assignee's successors, assigns and other legal representatives.



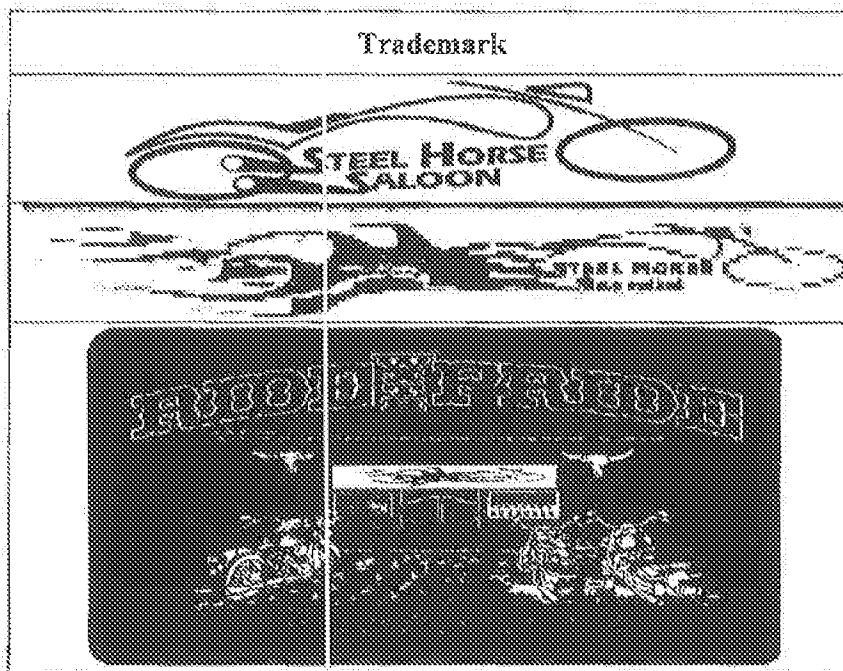
