TRADEMARK ASSIGNMENT

WHEREAS, Intel Corporation, a Delaware corporation with a principal place of business at 2200 Mission College Boulevard, Santa Clara, California 95052 U.S.A. (ASSIGNOR) has adopted, owned and/or used the trademarks (the "Marks") as described in Exhibit A, attached hereto and incorporated by reference herein, together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR agrees that ASSIGNOR hereby assigned unto ASSIGNEE effective as of 2/20/2014, all of ASSIGNOR's right, title, and interest of whatever kind in and to the Marks, together with (1) the associated goodwill; (2) all common law rights in the Marks; (3) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks; and (4) all rights to sue for past, present and future infringements or misappropriations of the Marks.

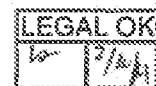
