**TERMINATION AND RELEASE OF SECURITY INTEREST
IN SELECTED TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN SELECTED TRADEMARK RIGHTS (this "Termination and Release"), dated as of February 18, 2014, from JPMorgan Chase Bank, N.A., a New York corporation, in its capacity as Collateral Agent (the "Agent") for the Secured Parties, to Del Monte Corporation, a Delaware corporation with principal offices at One Maritime Plaza, San Francisco, California 94111 (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to (i) that certain Security Agreement, dated as of March 8, 2011, among the Grantor, the other grantors party thereto and the Agent (together with all amendments, restatements, supplements and modifications, if any, from time to time made thereto, the "Security Agreement") and (ii) that certain Grant of Security Interest in Trademark Rights, dated as of March 8, 2011, between the Agent and the Grantor (the "IP Security Agreement"), the Grantor granted to the Agent for the benefit of the Agent and the other Secured Parties, a security interest (the "Security Interest") in certain collateral, including the Released Trademark Collateral (as hereinafter defined);

WHEREAS, the IP Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on April 8, 2011, at Reel 4517 and Frame 0117; and

WHEREAS, pursuant to the representations, warranties and certifications made by the Grantor, as more fully set forth in the Release of Security Interest, dated as of February 18, 2014, between the Agent and the Grantor (the "Release"), concerning the sale of the Released Trademark Collateral pursuant to that certain Purchase Agreement, dated as of October 9, 2013 (as amended, restated, supplemented or modified from time to time, the "Purchase Agreement"), among the Grantor, Del Monte Foods Consumer Products, Inc., a Delaware corporation (the "Purchaser"), and Del Monte Pacific Limited, the Agent now desires to terminate and release the entirety of its Security Interest in the Released Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Released Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest in, to and under the Trademarks (including the right to receive all Proceeds therefrom) specifically identified on Schedule A hereto. Unless otherwise defined herein or the context otherwise requires, terms used in this Termination and Release, including the preamble and recitals, have the meanings provided or provided by reference in the Security Agreement or the IP Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Released Trademark Collateral, and any right, title or interest of the Agent in such Released Trademark Collateral shall hereby cease and become void. The termination, release and discharge hereunder is limited solely, and only, to the Released Trademark Collateral, and shall not, in any manner, affect or deemed to affect the Agent's Security Interest in any other collateral, which Security Interest shall remain undisturbed and uninterrupted.
