CONFIRMATION OF TRADEMARK ASSIGNMENT

"**Meraki Marks**" means all of Meraki's trademarks, service marks, trade names, trade dress, logos, designs and slogans, in word mark, stylized and/or design formats, including without limitation Meraki's trademark registrations and applications and any and all of Meraki's common law rights in the aforementioned items, together with all goodwill associated with and symbolized by the aforementioned items, including without limitation the marks identified in Schedule 1 attached hereto and all of the goodwill associated with and symbolized by such marks.

Meraki has assigned and transferred, and CSI has received and accepted, all of Meraki's rights, title and interest throughout the world in and to the Meraki Marks and all the rights, claims and privileges pertaining to the Meraki Marks, including without limitation: the registrations and applications pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the Meraki Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Meraki in all matters related thereto.


Meraki hereby authorizes and requests the United States Commissioner of Patents and Trademarks and the relevant officials of foreign countries to implement this Assignment.

IN WITNESS WHEREOF, Meraki and CSI have caused this Assignment to be made as of the effective date of the Asset Transfer Agreement referenced above.
