RELEASE OF SECURITY INTEREST

This Release of Security Interest ("Agreement") is made and entered into as of the 30 day of Sept., 2013, by and between Gibson Brands Inc, formerly known as Gibson Guitar Corp. ("GIBSON") and SunTrust Banks, successor in interest to Perpetual Savings Bank FSB ("Creditor").

Creditor further acknowledges and understands that it has no interest of any kind or character, security or otherwise, in the IP or the proceeds therefrom.

2. Representations and Warranty. Creditor represents and warrants it has the power and authority to provide the release hereunder.

3. Miscellaneous. The represents the complete understanding of the parties and supersedes any prior or contemporaneous agreement regarding the subject matter herein.
