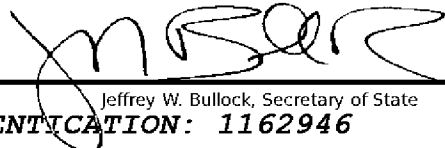

Pursuant to Section 251(c) of the General Corporation Law of the State of Delaware (the "DGCL"), Apteian, Inc., a Delaware corporation (the "Company"), in connection with the merger (the "Merger") of Apteian Holdings, Inc., a Delaware corporation ("Holdings"), with and into the Company, hereby certifies as follows:

FIRST: The names and states of incorporation of the constituent corporations to the Merger (the "Constituent Corporations") are:

FOURTH: The Merger shall become effective upon the filing of this Certificate of Merger with the Secretary of State of the State of Delaware in accordance with the DGCL.
