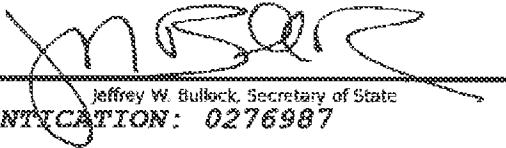

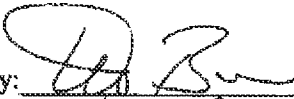
**THIRD:** The name of the surviving limited liability company is PolyOne Designed Structures and Solutions LLC.
