**TRADEMARK ASSIGNMENT**

**NOW, THEREFORE**, in consideration and exchange of the sum of one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by all parties, Assignors do hereby assign, sell, and transfer unto Assignee and its successors and assign Assignors' entire right, title, and interest in and to the DARBY Trademarks together with the common law rights and the goodwill of the business symbolized by the DARBY Trademarks and all claims and damages for past and future infringements thereof.

The parties hereto agree to execute, acknowledge and deliver all such further instruments, and to do all such other acts, as may be necessary or appropriate in order to carry out the intent and purposes of this Agreement.
