2. Agrees that any power of attorney or similar rights granted by Grantor to Secured Party under the Agreement is terminated; and
3. Authorizes and requests that the USPTO note and record the existence of the release hereby given.

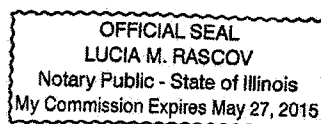
