

Declaration Regarding Correction of State of Incorporation

Author Solutions, Inc. hereby declares and affirms that it is the owner of the marks and registrations identified on Exhibit A, and records this correction to correct an inadvertent minor clerical error in which Applicant's state of incorporation was set forth as Indiana instead of Delaware at the time of filing certain applications and in certain declarations of use and for incontestable status under Sections 8 and 15 with respect to the registrations identified on Exhibit A.

Author Solutions, Inc. is the owner of the marks and changed its state of incorporation from Indiana to Delaware on February 2, 2007.
