Notice of such security interest was recorded against the Trademarks in the United States Patent and Trademark Office pursuant to the following:

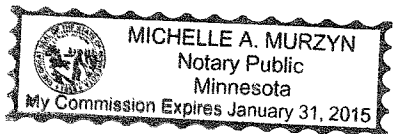


