RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”) is made as of February 28, 2014 (the “Effective Date”), by Bank of America, N.A., as collateral agent (in such capacity, the “Collateral Agent”), in favor of Sedgwick Claims Management Services, Inc. (the “Pledgor”).

WHEREAS, pursuant to the terms and conditions of (i) that certain Trademark Security Agreement between the Pledgor and the Collateral Agent dated as of June 12, 2013 (the “Trademark Security Agreement No. 1”) and (ii) that certain Trademark Security Agreement between the Pledgor and the Collateral Agent dated as of June 12, 2013 (the “Trademark Security Agreement No. 2”, together, with Trademark Security Agreement No.1, the “Trademark Security Agreements”), the Pledgor pledged and granted to the Collateral Agent a lien on and security interest in all of its right, title and interest in and to certain collateral identified in the Trademark Security Agreements set forth on Schedule I hereto including, without limitation, the goodwill associated therewith (collectively, the “Trademarks”);

WHEREAS, Trademark Security Agreement No. 1 and Trademark Security Agreement No. 2 were recorded with the Assignment Division of the U.S. Patent & Trademark Office on June 14, 2013, at Reel 5047 and Frame 0429 and on June 17, 2013, at Reel 5048 and Frame 0597, respectively;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreements, and hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the Trademarks arising under the Trademark Security Agreements.

If and to the extent the Collateral Agent has acquired any right, title or interest in or to any of the Trademarks, it hereby irrevocably re-assigns and re-transfers all such rights, title and interest to the Pledgor.

The Collateral Agent shall take all further actions, and provide to the Pledgor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgor, and at Pledgor’s cost and expense, to more fully and effectively effectuate the purposes of this Release.
