TRADEMARK ASSIGNMENT

WHEREAS, Monotype GmbH, a German corporation having a place of business at Werner-Reimers-Strasse 2-4, 61352 Bad Homburg, Germany (hereinafter "ASSIGNOR") has adopted, used and is using and is the owner of the marks and trademark registrations on Schedule A (hereinafter "the Trademarks").

WHEREAS, Monotype Imaging Inc., a Delaware corporation having a place of business at 500 Unicorn Park Drive, Woburn, Massachusetts 01801, USA (hereinafter "ASSIGNEE"), is desirous of acquiring the Trademarks;

WHEREAS, Assignee is already the owner of certain marks and registrations, similar to the Trademarks;

WHEREAS Assignor and Assignee are related companies, the Trademarks are deemed "Old IP" in the Share Purchase Agreement between Heidelberger Druckmaschinen AG and Monotype Imaging Holdings Corp. of August 1, 2006 and thus already attributed to the US branch of the Monotype group, the Trademarks are the subject of intercompany licenses, and the goodwill of the Trademarks are owned by the family of related entities but registered in the name of different related entities; and

WHEREAS Assignor and Assignee are desirous of consolidating ownership of the Trademarks, including the registrations and goodwill, to allow for unity of control and ownership, with licenses to the related entities.

NOW, THEREFORE, IT IS HEREBY AGREED:

1. In consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby sells, assigns and transfers to ASSIGNEE the entire right, title and interest in and to the Trademarks, together with the goodwill of the business in connection with which the Trademarks are used.

2. ASSIGNOR shall do all acts and execute all documents which may be reasonably required by ASSIGNEE in order to effect the assignment of the Trademarks and to ensure that the registrations be granted to ASSIGNEE.
