## TRADEMARK ASSIGNMENT

This Trademark Assignment is made as of **April 18, 2013** ("Effective Date") by **Aera Trucks, Inc.**, a Canada corporation, ("**Assignor**") and **Skate One Corp.**, a California Corporation ("**Assignee**").

WHEREAS, Assignor is the owner of the Trademark **AERA TRUCKS (STYLIZED)** Registration No. **4479843**, ("the Mark"), together with common law rights therein and the goodwill of the business symbolized thereby in connection with the goods on which the Mark is used ("Goods"); and

WHEREAS, Assignor desires to convey, transfer, assign, deliver, and contribute to Assignee all of its right, title, and interest in and to the Mark together with all common law rights and the goodwill of the business symbolized by the Mark;

NOW THEREFORE, for good and valuable consideration, including the provisions and covenants herein, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby sells, grants, conveys, transfers, assigns, delivers, and contributes to Assignee all of Assignor's right, title, and interest of whatever kind in and to the Mark in perpetuity, together with (1) the goodwill of the business appurtenant thereto and which is symbolized thereby relating to the Goods or otherwise; (2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Mark, including without limitation, damages, and payments for past or future infringements and misappropriations of the Mark; (3) all rights to sue for past, present, and future infringements or misappropriations of the Mark; and (4) the right to renew any trademark application or registration related to the Mark.

2. Assignor hereby appoints Assignee, with the full power of substitution therein, as its true and lawful attorney-in-fact for the limited purpose of executing such papers and performing such other proper acts as are reasonably necessary to secure to Assignee, or to its successors or assigns, the rights hereby transferred.

This Agreement has been executed as of the Effective Date.
