TRADEMARK ASSIGNMENT

This Trademark Assignment, effective as of October 29, 2013 ("Effective Date"), is between Windmill Health Products, LLC, a New Jersey limited liability company having a place of business at 6 Henderson Drive, West Caldwell, New Jersey 07006 ("Assignor"), and Spartan Brands, Inc., a corporation formed under the laws of the State of New York having a place of business at 451 Park Avenue South, New York, New York 10016 ("Assignee").

WHEREAS, Assignor is the owner of all of the right, title and interest in and to the trademark CITRISLIM (the "Mark"), U.S. Trademark Application Serial No. 86/032510 for the Mark (the "Application"), and all of the goodwill associated and connected with the Mark, and desires to assign, transfer and sell to Assignee the Mark, all of the goodwill associated therewith, and the Application; and

WHEREAS, Assignee is desirous of acquiring Assignor's entire right, title and interest in and to the Mark, all of the goodwill associated therewith, the portion of and the Application.

NOW, THEREFORE, for Twelve Thousand Five Hundred (\$12,500) and other fair and good consideration, Assignor, as of the Effective Date, hereby assigns, transfers and sells to Assignee, its successors, and assigns, Assignor's entire right, title and interest in and to the Mark, the goodwill associated therewith, the Application and any renewals thereof, all causes of action (in law and equity) and the right to sue, counterclaim, and recover for past, present, and future infringement, misappropriation, or dilution of the rights assigned to Assignee hereunder, and all rights, including the goodwill, corresponding thereto throughout the respective countries where Assignor holds or has applied for rights in the Mark.

Assignor, as of the Effective Date, agrees to immediately cease using the Mark and agrees, without further consideration, to cause to be performed such lawful acts and to execute such further documents regarding the rights assigned, transferred and sold herein, as reasonably requested by Assignee or its successors or assigns.

WHEREFORE, Assignor has duly executed this Trademark Assignment on the date indicated above.
