## **RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (the "Release") is made effective as of March 6, 2014, by and from Wells Fargo Capital Finance, LLC, a Delaware limited liability company (successor-by-merger to Wells Fargo Capital Finance, Inc., a California corporation), as Collateral Agent (the "Releasor"), to and in favor of CHECKERS DRIVE-IN RESTAURANTS, INC., a Delaware corporation ("Checkers"), RALLY'S OF OHIO, INC., an Ohio corporation ("Rally's"), CHECKERS & RALLY'S RESTAURANTS, INC. (f/k/a TAXI HOLDINGS CORP.), a Delaware corporation ("Checkers & Rally's"), CHECKERCO, INC., a Florida corporation ("Checkerco") and OFFICIAL BURGER OF TAMPA BAY, INC., a Florida corporation ("Official Burger") (collectively, the "Releasees").

WHEREAS, on March 14, 2011, the Releasees and the Releasor executed a Trademark Security Agreement (the "2011 Trademark Grant"), pursuant to which the Releasees granted to the Releasor, a continuing security interest in and to the Trademark Collateral (as defined in the 2011 Trademark Grant), including the trademarks listed on Exhibit A attached hereto;

WHEREAS, the 2011 Trademark Grant was recorded with the United States Patent and Trademark Office on March 15, 2011, at Reel/Frame 4496/0388;

WHEREAS, on November 9, 2012, the Releasees and the Releasor executed a Supplemental Trademark Security Agreement (the "November 9, 2012 Trademark Grant"), pursuant to which the Releasees granted to the Releasor, a continuing security interest in and to the Trademark Collateral (as defined in the November 9, 2012 Trademark Grant), including the trademarks listed on Exhibit B attached hereto;

WHEREAS, the November 9, 2012 Trademark Grant was recorded with the United States Patent and Trademark Office on November 12, 2012, at Reel/Frame 4898/0674;

WHEREAS, on November 15, 2012, the Releasees and the Releasor executed a Supplemental Trademark Security Agreement (the "November 15, 2012 Trademark Grant"), pursuant to which the Releasees granted to the Releasor, a continuing security interest in and to the Trademark Collateral (as defined in the November 15, 2012 Trademark Grant), including the trademarks listed on Exhibit C attached hereto (together with the trademarks listed on Exhibit A and Exhibit B, the "Released Trademarks");

WHEREAS, the November 15, 2012 Trademark Grant was recorded with the United States Patent and Trademark Office on November 15, 2012, at Reel/Frame 4901/0653; and

WHEREAS, the Releasees have satisfied and fulfilled all of their obligations to release the Releasor's security interest in the trademarks.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

SECTION 1. The Release. The Releasor hereby terminates, releases, and discharges any security interest in, and right of setoff against, all of the Releasees' right, title and interest in, to and under the Released Trademarks.

SECTION 2. Further Assurances. The Releasor hereby authorizes the Releasees or the Releasees' authorized representative to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Releasor in the Released Trademarks and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Releasor further agrees to execute and deliver to the Releasees any and all further documents and instruments, and do any and all further acts which the Releasees (or its agents or designees) reasonably request (at the Releasees' sole cost and expense) in order to confirm this Release and the Releasees' right, title and interest in, to and under the Released Trademarks.

SECTION 3. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.
