Whereas, Assignor owns the trademark shown on the attached Schedule, and the goodwill of the business in connection therewith (the "Trademark").


Whereas, Assignee desires to purchase and acquire, and Assignor desires to sell, assign and transfer to Assignee, the Trademark.
