Assignor hereby authorizes and requests the officials of the United States Patent and Trademark Office and the corresponding officials of any and all other countries worldwide to issue any and all trademark registrations for the Trademarks, when granted, to Assignee, as Assignee of Assignor's entire right, title and interest in and to the same, for the sole use and benefit of the Assignee, its successors and assigns.

Assignor also agrees that it will reasonably cooperate with Assignee to fully carry out the terms of this assignment and that it will promptly sign and/or deliver to Assignee all documents which may be reasonably necessary to record this assignment and any prior assignments or other transfers of ownership of the Trademarks in any country of the world and otherwise perfect Assignee's ownership of the Trademarks.

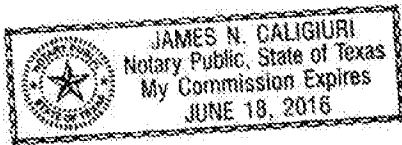
