### **THIRD AMENDMENT TO TRADEMARK SECURITY AGREEMENT**

This THIRD AMENDMENT TO TRADEMARK SECURITY AGREEMENT (this "Amendment"), dated as of March 7, 2014 is delivered pursuant to that certain Trademark Security Agreement dated as of August 10, 2007 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Agreement") as amended by that certain First Amendment to Trademark Security Agreement dated as of June 28, 2010, and that certain Second Amendment to Trademark Security Agreement dated as of September 30, 2012, by and among EURO-PRO OPERATING LLC, a Delaware limited liability company ("EP Operating"), EP MIDCO LLC, a Delaware limited liability company ("EP Midco") and EURO-PRO SALES COMPANY, a Delaware corporation ("EP Sales" and together with EP Operating and EP Midco, collectively, "Borrowers"), EURO-PRO INTERNATIONAL HOLDING COMPANY, a Delaware corporation ("EP International") and EURO-PRO MANAGEMENT COMPANY, a Delaware corporation ("EP Management" and together with EP International, collectively, "Initial Guarantors") (the Borrowers and the Initial Guarantors sometimes collectively referred to as "Grantors" and individually as a "Grantor"), in favor of BANK OF AMERICA, N.A., a national banking association, in its capacity as Agent ("Agent") for itself and the Lenders from time to time party to the Loan Agreement, as hereinafter defined ("Lenders"), the Trademark Security Agreement being recorded on August 16, 2007 as Reel/Frame 003602/0771 with the U.S. Trademark Office, the First Amendment to Trademark Security Agreement being recorded on July 6, 2010 as Reel Frame 004237/0358, and the Second Amendment to Trademark Security Agreement being recorded on December 4, 2012, at Reel Frame 4912/0159.

#### **WITNESSETH:**

**WHEREAS**, certain of the Grantors are indebted to the Agent and the Lenders pursuant to that certain Third Amended and Restated Loan and Security Agreement dated as of March 7, 2014 (as such agreement may be amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement"); and

**WHEREAS**, the Grantors have provided Agent with notice that they have obtained additional Trademarks;

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants and agreements hereinafter set forth, each Grantor and the Agent agree as follows:

1. AMENDMENT OF GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Schedule I of the Trademark Agreement is hereby amended as of the date hereof to include the Trademarks set forth on the schedules attached hereto; provided, that no such amendment or restatement shall release or be deemed to release any security interest in any present or future Trademark granted to Agent and the Lenders as collateral pursuant to the Trademark Agreement.

2. SECTION TITLES. The Section titles contained in this Trademark Security Agreement are and shall be without substantive meaning or content of any kind whatsoever and are not a part of the agreement between the parties hereto.


3. COUNTERPARTS. This Trademark Security Agreement may be executed in any number of counterparts, each of which shall collectively and separately constitute one and the same agreement.
