SEVENTH: The Agreement of Merger is on file at 117 West Napa Street, Suite C, Sonoma, CA 95476, an office of the surviving corporation.

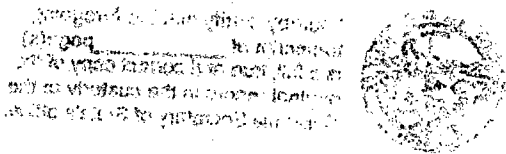
EIGHTH: A copy of the Agreement of Merger will be furnished by the surviving corporation on request, without cost, to any stockholder of the constituent corporations.
