Assignee desires to acquire all right title and interest in the Trademark, the good will symbolized by the mark, and the registration of the Trademark.


WHEREAS the Assignor assigns, sells and transfers unto the Assignee all of the Assignor's rights, title and interest in and to the Trademarks and the Application;

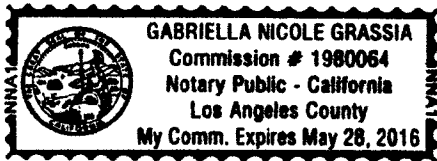

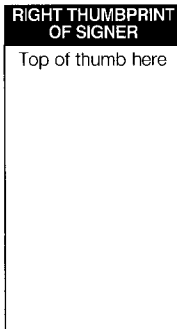

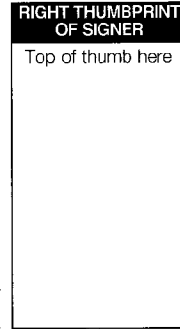
