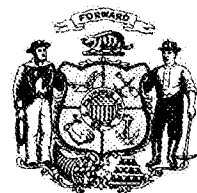

The undersigned corporation, in accordance with Section 180.1104 of the Wisconsin Business Corporation Law (the "WBCL"), hereby executes the following Articles of Merger:

1. The parties to the merger are:
 - (a) Hoffmaster Group, Inc., a Delaware corporation ("Parent"), and
 - (b) Graphic Management Specialty Products, Inc., a Wisconsin corporation ("Subsidiary").
2. Parent owns all of the issued and outstanding stock of Subsidiary.
3. The surviving corporation (the "Surviving Corporation") is Hoffmaster Group, Inc., and the Certificate of Incorporation of Hoffmaster Group, Inc. shall be the Certificate of Incorporation of the Surviving Corporation until amended in accordance with law.
4. A plan of merger (the "Plan of Merger") was approved and adopted by Parent and Subsidiary in accordance with Section 180.1104 of the WBCL.
5. The Plan of Merger is on file at the principal place of business of the Surviving Corporation.
6. The Surviving Corporation will provide a copy of the Plan of Merger, upon request and without cost, to any shareholder of a corporation that was a party to the merger or, upon payment to the Surviving Corporation of an amount equal to the cost of producing the copy, to any other interested person.
7. Subsidiary, which is the non-surviving corporation, does not have a fee simple ownership interest in any Wisconsin real estate.
8. The Surviving Corporation is the direct parent of Subsidiary. Therefore, the merger approval provisions of Section 180.11045 of the WBCL are not applicable with respect to this merger.
9. The Effective Time of the Merger shall be at 11:59 p.m. on December 29, 2013.

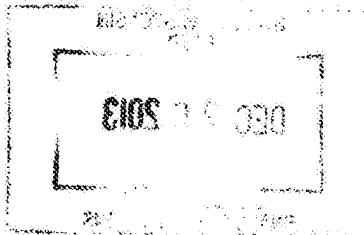
